**NOTICE** is hereby given that a public meeting of the **Appraisal Review Board**, hereinafter referred to as **ARB**, of **Hidalgo County Appraisal District** will convene at **9:00 a.m. on August 14, 2023** to hear and determine taxpayer appeals on all matters permitted by the **TEXAS PROPERTY TAX CODE, CHAPTER 41** and will continue in session until all timely filed appeals have been heard and resolved (see Exhibit "A" for times and dates). The hearings will be conducted by videoconference, teleconference, and in person at Hidalgo County Appraisal District located at **4405 S. Professional Dr. Edinburg, Tx.** After all timely protests have been heard; the Appraisal Review Board will approve the 2023 Appraisal Records.

**If during the course of the meeting, the ARB should determine that a closed or executive session of the Board is required, then such closed or executive session or meeting is authorized by Section 551.071–551.084 et seq. of the Texas Government Code. Notice of the closed or executive session will be given after the commencement of the meeting covered by this notice.**

Should any final action, final decision, or final vote be required in the opinion of the ARB with regard to any item during the meeting, then such final action, final decision, or final vote shall be made during the opening covered by this notice upon the reconvening of this public meeting.

The affidavit states the ARB, has not communicated with anyone concerning the property under protest, except during the hearing or at another hearing in which the property was used as evidence.
  - b. The ARB will hear scheduled protests-motions from property owners/agents on clerical errors, multiple appraisal, non-existent property, and failure to give notice, affidavits and correspondence from taxpayers.
  
7. **Appraisal Review Board hearings on 2023 taxpayer's protests under Section 41 of the Property Tax Code on records submitted May 16, 2023 (Action Item)**
  - a. The ARB will administer the Oath to property owners and/or agents as well as Hidalgo County Appraisal District representatives who are present to provide evidence on their protest.
  - b. The ARB will hear scheduled protests-motions from property owners/agents on clerical errors, multiple appraisal, non-existent property, and failure to give notice, affidavits and correspondence from taxpayers.
  
8. **Consideration and Possible Action to Correct the 2023 and Prior Year Records on Recommendation by the Chief Appraiser (Action Item)**
  - a. Recommendation from Chief Appraiser to correct 2022 and prior year omitted records submitted by mail to the ARB-Section 41.10 PTC.
  - b. Recommendation from Chief Appraiser to Correct Prior Years Appraisal Roll-Section 25.25.
  - c. Recommendation from Chief Appraiser to Correct Appraisal Roll-Section 25.25(b).
