NOTICE is hereby given that on the **16th day of January, 2024**, the Appraisal Review Board of Hidalgo County Appraisal District, hereinafter referred to as ARB, will hold a **PUBLIC HEARING ON THE 2024 APPRAISAL REVIEW BOARD HEARING PROCEDURES AT 9:00A.M.**, immediately followed by a **REGULAR SCHEDULED MEETING**. The meeting will be held at Hidalgo County Appraisal District located at 4405 S. Professional Dr. Edinburg, Tx. being the location at which a required quorum will be physically present.

To the extent that any member of the ARB elects to appear by video conference calling, all requirements related to such appearance as set forth in Section 551.127. TEXAS GOVERNMENT CODE, will be applicable.

If during the course of the meeting, the ARB determines that a closed or executive session is required, then such closed or executive session or meeting is authorized by Sections 551.071--551.084 et seq. of the Texas Government Code. Notice of the closed or executive session will be given after the commencement of the meeting covered by this notice.

Should any final action, decision, or vote be required in the opinion of the ARB with regard to any item during the meeting, then such final action, decision, or vote shall be made during the open meeting covered by this notice upon the reconvening of this public meeting.
