NOTICE had been posted that on the above date and time, the Appraisal Review Board of Hidalgo County Appraisal District, hereinafter referred to as ARB, would hold a meeting at 4405 S Professional Dr., Edinburg, Texas to consider protests filed for 2020 and prior years, and motions from the Chief Appraiser to correct 2020 and prior year records. Following is the record of the proceedings.

ITEM 1. Declaration of Quorum and Call to Order- Ms. Kellie Flores, Chairman of the ARB, determined a quorum was present and called the meeting to order at 9:00 a.m.

ITEM 2. Pledge of Allegiance- Ms. Kellie Flores, Chairman of the ARB, asked Mr. John Flores, Member of the ARB, to lead everyone present in the pledge of allegiance.

ITEM 3. Review and Consider Approval of the Minutes for the Meeting held February 16, 2021-

A motion was made by Mr. John Flores, Member of the ARB, and seconded by Mr. Oscar Cuellar, Member of the ARB, to approve the minutes held on February 16, 2021. The motion passed unanimously.

ITEM 4. Public Comments- No taxpayers were present for public comments

ITEM 5. Discussion on Pending Litigation- No discussion on Pending Litigation

ITEM 6. Consideration and Possible Action to Accept the Appraisal Records for 2020 and Prior Year Omitted Records-

Hearing for taxpayer's protests - The ARB will hear scheduled protests, motions from property owners/agents on clerical errors, multiple appraisals, non-existent property, one-third over-appraisal errors, joint motions on incorrect appraised values, failure to give notice, affidavits and correspondence from taxpayers, The Chairperson shall Schedule hearings by the board or panels of the Board—Thirty-nine accounts were scheduled for March 16, 2021. Ms. Kellie Flores, Chairman of the ARB, assigned Panels A, B, & C to conduct protest hearings. One account was presented to offer evidence in Panel B. Two accounts were presented to offer evidence to Panel C. After the review of the accounts for Panel B, a motion was made by Ms. Rosa Ybarra, Secretary of the ARB and seconded by Mr. Eloy Barrientes, Member of the ARB to approve the accounts presented. - (b.) Batched books which included corrections for ARB approval were presented to the ARB by the Chief Appraiser. After the review, a motion was made by Ms. Rosa Ybarra, Secretary of the ARB, and seconded by Mr. Joe Barrera, Vice-Chairman of the ARB, approving the corrections for prior years appraisal roll. The motion passed unanimously.
- (c.) A motion was made by Mr. John Flores, Member of the ARB, and seconded by Mr. Eloy Barrientes, Member of the ARB, to accept the Appraisal records as submitted. The motion passed unanimously.

There being no taxpayers needing to be heard, Ms. Rosa Ybarra, Secretary of the ARB, made a motion that the ARB accept the recommendation, if any, From the Chief Appraiser on protests where taxpayers did not appear to offer evidence. Additionally, if no recommendation is made by the Chief Appraiser, NO ACTION is taken on the remaining protests. The motion was seconded by Mr. John Flores, Member of the ARB, and Passed unanimously.
