NOTICE had been posted that on the above date and time, the Appraisal Review Board of Hidalgo County Appraisal District, hereinafter referred to as ARB, would hold a meeting at 4405 S Professional Dr., Edinburg, Texas to consider protests filed for 2021 and prior years, and motions from the Chief Appraiser to correct 2021 and prior year records. Following is the record of the proceedings.

ITEM 1. Declaration of Quorum and Call to Order- Ms. Kellie Flores, Chairman of the ARB, determined a quorum was present and called the meeting to order at 9:00 a.m.

ITEM 2. Pledge of Allegiance- Ms. Kellie Flores, Chairman of the ARB, asked Ms. Rosa Ybarra, Secretary of the ARB, to lead everyone present in the pledge of allegiance.

ITEM 3. Review and Consider Approval of the Minutes for the Meeting held August 4, 5, 9, 10, 11, and 12, 2021-

A motion was made by Mr. Joe Barrera, Vice-Chairman of the ARB, and seconded by Mrs. Ramona Barron, Auxiliary Member of the ARB, to approve the minutes held on August 4, 5, 9, 10 11, 12, 2021. The motion passed unanimously.

ITEM 8. Hearings for Taxpayers Protests-

- (a.) For the record the oath was not administered. No action
- (b.) For the record no accounts were scheduled for August 17, 2021. No action

ITEM 9. Consideration and Possible Action to Correct the 2021 and Prior Year Records on Recommendation by the Chief Appraiser-

(a.) A motion was made by Mr. Eloy Barrientes, Member of the ARB, and seconded by Ms. Rosa Ybarra, Secretary of the ARB, to accept The appraisal records as submitted by the ARB Coordinator. The motion passed unanimously.

(b.) Batched books which included corrections for ARB approval were presented to the ARB by the Chief Appraiser. After the review, a motion was made by Mr. John Flores, Member of the ARB, and seconded by Mr. Oscar Cuellar, Auxiliary Member of the ARB, approving the corrections for prior years appraisal roll. The motion passed unanimously.

(c.) A motion was made by Mrs. Graciela Farias, Member of the ARB, and seconded by Mrs. Ramona Barron, Auxiliary Member of the ARB, to accept the Appraisal records as submitted. The motion passed unanimously.

ITEM 10. Non-Present Motion-

(a.) A motion was made by Mr. Joe Barrera, Vice-Chairman of the ARB, and seconded by Mr. Eloy Barrientes, Member of the ARB, to accept the recommendation from the Chief Appraiser on protest where the owner/agent provided information resulting in an agreed value. The motion passed unanimously.

(b.) Ms. Rosa Ybarra, Secretary of the ARB, asked if there were any remaining protesters on the list that desired to be heard. There being no taxpayers needing to be heard, Ms. Rosa Ybarra, Secretary of the ARB, made a motion that the ARB accept the recommendation, if any, from the Chief Appraiser on protests where taxpayers did not appear to offer evidence. Additionally, if no recommendation is made by the Chief Appraiser, **NO ACTION** is taken on the remaining protests. The motion was seconded by Mr. Oscar Cuellar, Auxiliary Member of the ARB, and Passed unanimously.

ITEM 11. Consideration and Possible Action to Approve of 2021 and Prior Year Omitted Records-Section 41.12 PTC-

(a.) A motion was made by Mrs. Ramona Barron, Auxiliary Member of the ARB, and seconded by Mr. John Flores, Member of the ARB, approving the 2021 and prior year omitted records as presented by the Chief Appraiser.

(b.) A motion was made by Mrs. Graciela Farias, Member of the ARB, and seconded by Ms. Annette Valadez, Member of the ARB certifying all protest and challenges have been heard.
